Pursuant to G.S. 150B-3(c), the North Carolina State Board of Dental Examiners (Board) finds that the public health, safety, and welfare requires emergency action and hereby summarily suspends License Number 8522 and Permit Number 0522 issued to Kiya Green, D.D.S. (Respondent), effective upon ENTRY of this Order. This Order is entered based on evidence received during a Board investigation, including during a sedation inspection and interview with Respondent and her staff and a subsequent confidential evaluation report received by the Board through the North Carolina Caring Dental Professionals Program (CDP) concluding that Dr. Green suffers from a medical condition making her unfit and not safe to practice dentistry at this time. Dr. Green has consistently and fully cooperated with the Board and CDP.

Respondent shall immediately cease the practice of dentistry in North Carolina and surrender her license, permit, and current renewal certificates pending further order from the Board.

The Board's summary suspension is not a Final Agency Decision concerning Respondent's moderate sedation permit or her dental license. The summary suspension shall remain in effect while the investigation is pending and until further Order of the Board or a Final Agency Decision is entered.

STATEMENT OF CONSENT

I, Kiya Green, D.D.S., do hereby certify that I have read the foregoing Consent Order Summarily Suspending License and Moderate Sedation Permit and agree to it. By assenting to this Consent Order, I am not admitting to any potential violations of the Dental Practice Act or the Board's regulations. I understand that:

- The Board staff may make unannounced visits to my dental office, if open for administrative purposes, to ensure full compliance with this Consent Order and may request documentation to determine compliance;
- The Board will report the contents of this Consent Order to the National Practitioner Data Bank and that it will become part of the Board's public record;
- The investigation is still ongoing, no decision has been made about whether to issue a notice of contested case hearing and, as a result, I agree that no proceeding will be promptly commenced and determined pursuant to N.C. Gen. Stat. 150B-3(c); and
- I waive any ability or potential right to challenge, seek judicial review, or appeal the entry and enforcement of this Consent Order.

I freely and voluntarily enter into this Consent Order, acknowledge that I have not been forced or coerced to sign this Consent Order, and have been afforded the opportunity to consult with counsel before signing it. I consent to service of the Consent Order via email and waive service by any other method.
