**SUMMARILY SUSPENDING
LICENSE**

Pursuant to G.S. 150B-3(c), the North Carolina State Board of Dental Examiners (Board) finds that the public health, safety, and welfare requires emergency action and hereby summarily suspends License Number 10984 issued to Gregory J. Keiser, D.M.D. (Respondent), effective upon ENTRY of this Order. This Order is entered based on a report and documentation received by the Board by a recent employer that Respondent: (1) has been inhaling nitrous oxide in the office during office hours and more specifically between seeing patients clinically, (2) admitted this conduct to his prior employer, and (3) has a prior substance abuse history and has relapsed.

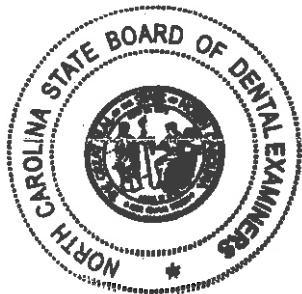
Based on the information received, including credible information and documentation that he has used impairing substances while treating patients, the Board finds and concludes that the public health, safety, and welfare require emergency action and the summary suspension of Respondent's license. Therefore, Respondent shall immediately cease the practice of dentistry in North Carolina and surrender his license and current renewal certificate pending further order of the Board.

Formal proceedings in this matter will be promptly commenced and determined if Respondent submits a written request for a formal hearing to the Board. Absent such a written request, a formal hearing will be scheduled as soon as practicable. Respondent will be served with a Notice of Hearing containing the allegations to be heard in accordance with G.S. 150B-38(b).
