Pursuant to G.S. 150B-3(c), the North Carolina State Board of Dental Examiners (Board) finds that the public health, safety and welfare requires emergency action and hereby summarily suspends License Number 108737 issued to Ceasar R. Marston D.M.D. (Respondent), effective upon service of this Order. This action is being taken based on information and evidence recently received by the Board indicating that Respondent has committed serious violations of the Dental Practice Act and the Board's regulations related to his treatment of pediatric patients and his interactions with other personnel at the former dental office at which he worked until recently. Based on that information, it is the Board's opinion that Respondent currently constitutes a threat to the public health, safety, and welfare. Therefore, Respondent shall immediately cease the practice of dentistry in North Carolina and surrender his license and current renewal certificate pending further order of the Board.

The Board's summary suspension is not a final agency decision concerning whether the alleged violations occurred or Respondent's ability to practice dentistry in the future. If Respondent submits a written request for a formal hearing to the Board,

contested case proceedings in this matter will be promptly commenced and determined, once the Board's investigation is completed. Absent such a written request, a contested case hearing will be scheduled as soon as practicable. Respondent will be served with a Notice of Hearing containing the allegations to be heard in accordance with G.S. 150B-38(b). The summary suspension shall remain in effect while the investigation is pending and until further order of the Board.

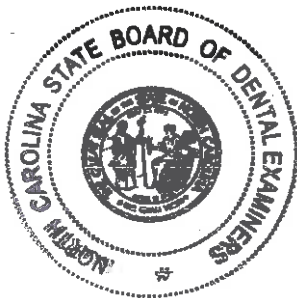


